#### 5. Who will have the access to you personal data?

We will make sure that your data are processed only in accordance with the purpose mentioned above. If this is necessary to fulfil the mentioned purpose, your data will be approached by authorized employees from our company.

- b) If we engage another person to perform certain tasks of the processor, but we have to stress out that such processor shall operate exclusively by our instructions and orders and in such case we will ensure all protection measures regarding your personal data and as well that all mentioned tasks will be performed by ourselves.

6. Where will my data be processed?
